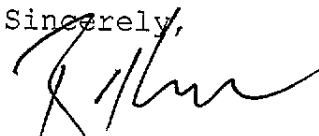

The business of the corporation shall be managed by the stockholders and there shall be no directors.

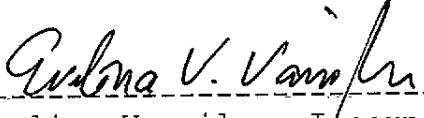

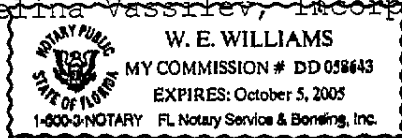
The corporation shall have a President, Vice President, Secretary and Treasurer. One individual may fill all positions.

The maximum number of shares of stock that this corporation is authorized to have issued and outstanding at any one time is 5,000.

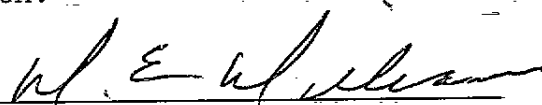
