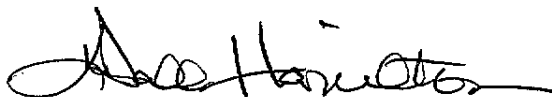

ARTICLES OF INCORPORATION OF

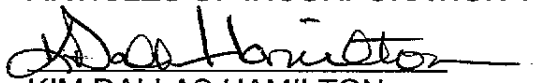
