

ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of this corporation is: **MCK MEDICAL INVESTMENTS, INC.**

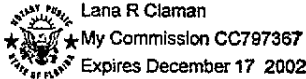
