Dear Sir or Madam:

On February 1, 2004 our office was retained by AFT Signs for accounting services. We have been trying to resolve several of the problems we have found with their paperwork, which was previously handled by a paralegal service. Their corporate dissolution is one of the problems which arose.

We believe the timeline of events to be as follows: AFT Signs never received the original UBR because their office moved and the mail wasn't forwarded to their new office. There has been some communication between AFT Signs and your office. In October 2003 AFT was notified that the corporation had been dissolved, he immediately mailed the \$150.00 annual report fee along with a letter explaining that he never received the original report and that was the reason it was filed late. It appears that the check was separated from the letter but the check was cashed. AFT then received a notice from your office stating that it needed a letter stating non-receipt of the UBR in order to waive the reinstatement fee. Another letter was mailed to your office in January 2004 regarding this issue along with another \$150.00 for the 2004 annual report fee; AFT inadvertently left out the completed Application for Reinstatement. I spoke to someone at your office and was told that this \$150.00 was returned to AFT on 2/3/04.

Enclosed please find their Application for Reinstatement along with a check for \$150.00 for the 2004 annual report fee. We respectfully request that you process this application and waive the reinstatement fee. We understand that there have been some delays in AFT's response time, however the original delay was due to non-receipt of the original UBR. Any help will be greatly appreciated.
