- 1) The original return was filed late.
- A letter was sent on 06/11/2003 stating the delinquency of my original return. 2)
- My corporation was dissolved on 09/19/2003 due to no response to this letter. 3)
- The address listed as my mailing address is incorrect. 4)

## In response to the above items:

- 1) The accountants who originally filed my Articles of Incorporation never informed me of the fact that an annual report was due in order to keep an 'active' status with the Division of Corporations.
- I never received the notices 1 or 2 of the 2003 Uniform Business Report due 2) to a change in my business address. It was not until a meeting with my accountant back in June that I realized the filing requirements for this report. I used the Division of Corporation's website to produce a blank form to file the first UBR. A check for \$150 was included as payment for the annual registration.

Also, my \$150.00 check written to the Department of State was cashed. Due 4) to the fact that this check was cashed, I assumed that my UBR was filed timely and my corporation was still active.

It has come as a great confusion to me as to why I never received any documentation from the Division of Corporations since I changed my address. After speaking with the representative I can understand why now. Please correct my mailing address with your files.
