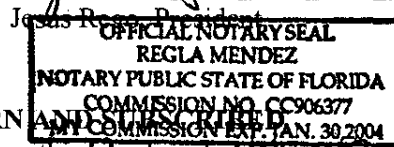
1. Jesus Rego is the President of CENTRAL COMFORT APPLIANCE CORP., a Florida corporation, (hereinafter "Corporation").
