**ARTICLES OF INCORPORATION

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is COMPUTER SYSTEM DOCTOR and its principal place of business shall be located at 115 Calabria Avenue #2, Coral Gables, Florida. 33134

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business of Computer Repair and Service.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Hundred (100) shares of common stock at One Hundred Dollars (\$100.00) par value, which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 115 Calabria Avenue #2, Coral Gables, Florida, and the name of the initial registered agent of this corporation at that address is DANIEL CIRIGLIANO.

ARTICLE VII - DIRECTORS

Initially, this corporation shall have ONE (1) Director who shall serve until their successors shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors. ARTICLE X - INDEMNIFICATION

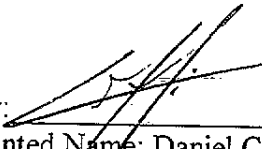

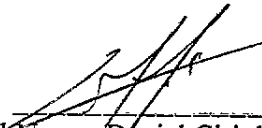
