ARTICLE I
NAME OF CORPORATION

The name of the Corporation is Palmer Auto Body Shop, Inc.

ARTICLE II

The principal office of the Corporation is located at 1321 Church Street, Orlando, FL 32805.

ARTICLE III

The street address of the initial registered agent of the Corporation is 1301 Ballentyne Place, Apopka, FL 32703, and the initial registered agent at that address is Frank Nam.

ARTICLE IV

The general nature of the business to be transacted by the Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE V

The affairs of this Corporation shall be managed initially by a Board of two (2) Directors. The number of Directors may be changed by amendment of the by-laws of the Corporation. 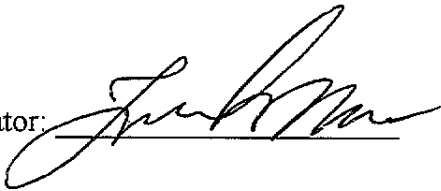
