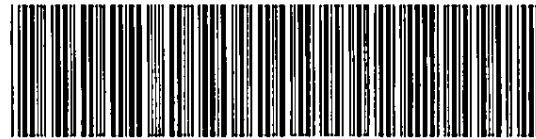

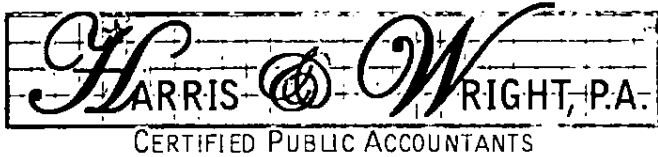



The name of the corporation is VIRGINIA C. HARRIS, P.A.

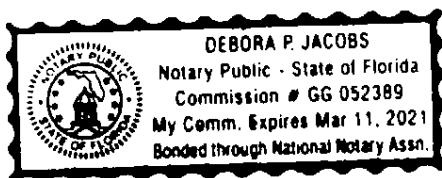


