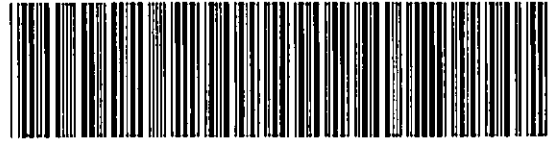

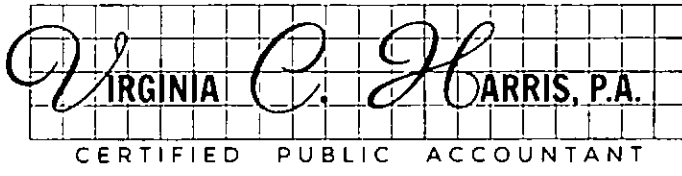



**The name of the corporation is Harris & Hahn, P.A.**

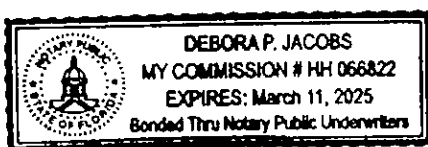
