ARTICLE I - NAME

The name of this corporation is DoneRite Installations Corp.

ARTICLE IX - AMENDMENT

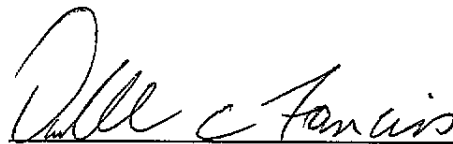

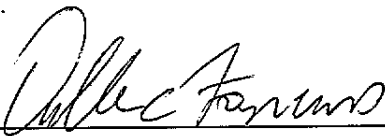
