


The undersigned, acting as the incorporators of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation:


1. The name of the corporation is Detour Travel, Inc.
2. The address of the corporation is 441 12th Place, SE, Vero Beach, Florida 32962.
3. The period of its duration is perpetual.
4. The purpose is to organize, book, direct, assist and manage travel tours for the general public and groups of travelers as members of clubs, commercial and private enterprises and any other agencies requiring travel, food, lodging assistance and any other business permitted under the laws of the United States and Florida.



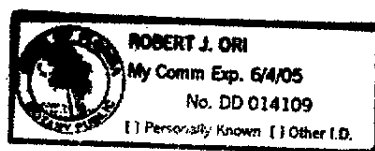
