ARTICLE I – NAME

The name of the Corporation is O's Tropical Janitorial Service Inc.

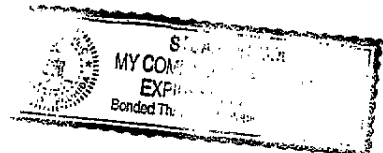
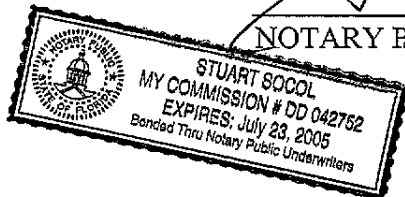
