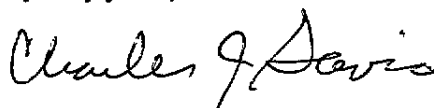

OF

ARTICLE I.
NAME AND PRINCIPAL ADDRESS

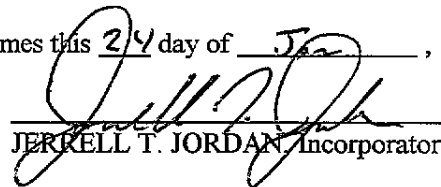
**ARTICLE IX.

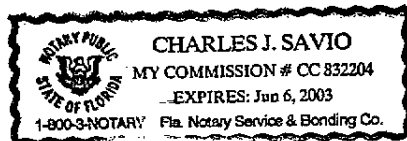
