**THE UNDERSIGNED**, acting as sole incorporator of **JLS BUSINESS COMMUNICATIONS SPECIALISTS, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I**

Name

The name of the Corporation is JLS BUSINESS COMMUNICATIONS SPECIALISTS, INC.

**ARTICLE II**

Corporate Purposes, Power, and Rights
