

### ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as sole incorporator of JLS BUSINESS COMMUNICATIONS SPECIALISTS, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

#### **ARTICLE I**

#### Name
