ARTICLES OF INCORPORATION
OF

SOLAN PROPERTIES USA, INC.

ARTICLE I - NAME

The name of this corporation is SOLAN PROPERTIES USA, INC., whose principal office or mailing address is 2973 West S.R. 434, #400, Longwood, Florida 32779.

ARTICLE II - DURATION

As provided in Florida Statutes, Chapter 607, this corporation shall exist in perpetuity.

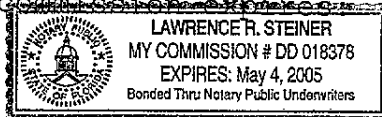


