ARTICLE I - CORPORATE NAME

The name of the corporation shall be:

ARTICLE II - DURATION

This Corporation shall exist perpetually commencing on the date these Articles are filed and until dissolved according to Florida law.

ARTICLE XI – INDEMNIFICATION


This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.
