The name of this corporation shall be:

ARTICLE III

The general nature of the business and objects and purposes proposed to be transacted and carried on by this corporation are:
To deal with all facets of the entertainment world, mainly dealing with music. To find, produce, promote, and distribute the best new music worldwide. This corporation ventures will also include movies, books and magazines production and distribution. Other productions will be executed, not to exclude comedy, dance, theatrics, etc. To do all the things herein mentioned, as fully and to do the same extent as natural persons might do, viz:

- (1) Transact these in all lawful business
- (2) Said corporation shall further have power; to have perpetual succession by its corporate name; to sue and be sued, complain, and defend in its corporate name in all or proceedings; to have a corporate seal, which may be altered at pleasure, and to use the same by using it, or a facsimile thereof, to be impressed affixed, or in any other manner reproduced.

To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use and otherwise deal in dispose of all or any part of its property and assets;

To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise, dispose of all or any part of its property and assets;
To lend money to, and use its credit to assist, its officers and employees in accordance with a Florida Statute S607.141;

To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interest in, or obligations of the United states or any other government, state, territory, governmental district, or municipality or of any instrumentality thereof;

To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its note, bonds and other obligations, and secure any of its property, franchises, and income;

To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security of the payment of funds so loaned or invested;

To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this state;

To elect or appoint officers and agents of the corporation and define their duties and fix their compensation;

To make and alter bylaws, not inconsistent with its articles of incorporation or with the laws of this state;
