ARTICLE VI

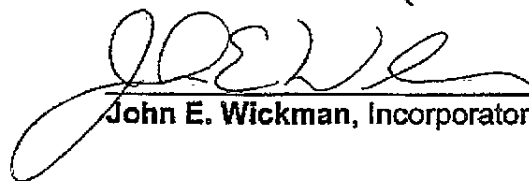
