ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the Corporation is SHE'S GOT IT, INC.

ARTICLE II - DURATION

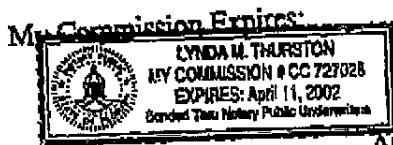
