The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation.

ARTICLE I. NAME

The name of the corporation is DIXIE PECAN COMPANY.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 8943 Rose Hill Drive South, Jacksonville, FL 32221.

ARTICLE III. CAPITAL STOCK
