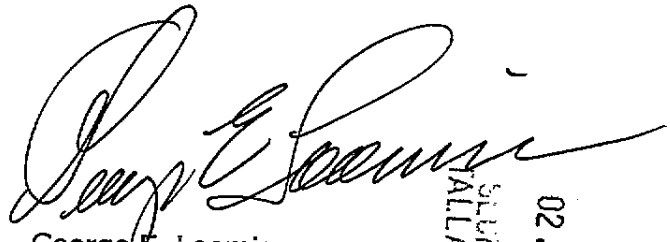

**ARTICLE I.
NAME**

The name of the corporation shall be: GFSW, Inc.

**ARTICLE II.
DURATION**

The duration of the corporation shall be perpetual and its existence shall commence February 1, 2002.

**ARTICLE III.
PURPOSE**
