**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME & ADDRESS**

The name of this Corporation is **REFERRAL REALTY OF LAKE COUNTY, INC.** The principal office, if known, or the mailing address of the Corporation is 51 Old Mt. Dora, Road, Eustis, Florida 32726.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III - PURPOSE**

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

**ARTICLE IV - SHARES**

The aggregate number of shares which the Corporation is authorized to issue is 1,000 shares of common stock. Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial Registered Office of the Corporation is 1938 Maple Circle, Tavares, Florida 32778-2036, and the name of its initial Registered Agent at that address is **Philip J. Cochran**.

## ARTICLE VI - INITIAL BOARD OF DIRECTORS






