The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby associates herself to form a corporation under the laws of the State of Florida and in compliance with Chapter 607 and /or Chapter 621, F.S.. These Articles of Incorporation may be amended only by the unanimous vote of the stockholders.
