ARTICLES OF INCORPORATION OF COCHRANE CAPITAL, INC.

In compliance with the requirements of F.S. Chapter ANAMAGNEE, FLORIDA undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I
