
Re: Toyopan, Inc. – Reinstatement Application

I understand from talking to an examiner over the telephone that Toyopan, Inc. was dissolved because I inadvertently failed to include the name of the sole Director, Mr. Francisco José Arguedas, on the UBR form. While this is true, it is also true that I did not receive the second notice (supposedly sent out to 8550 NW 17th St., Ste. 100, Miami, FL 33126) informing me that Toyopan, Inc. would be dissolved on or after September 10 if the error were not corrected before that date. Had I received such a notice in a timely fashion, I would have corrected the error in time to avoid administrative dissolution.
