ARTICLES OF INCORPORATION

OF

SOUTH FLORIDA PAINTING AND HOME SERVICES, INC.

The undersigned, acting as subscribers of a corporation under the Florida Corporation Law, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the Corporation is:

The purpose for which the corporation is organized is to engage in any activities or business permitted under the laws of the United States and Florida.

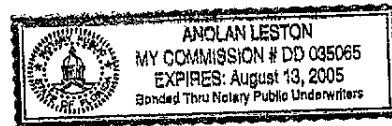
