Article VII – Registered Agent

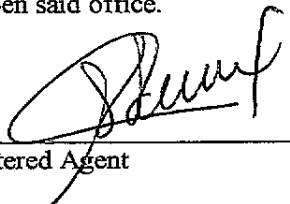

Article XIII – Amendment

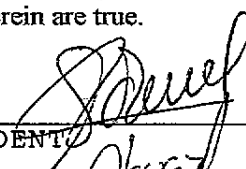

Article – Fourteen

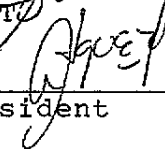

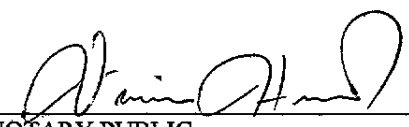
