# **ARTICLES OF INCORPORATION** PRESTIGE AIR CONDITIONING SERVICES, INC.

OZFEB-, SD MID: OB The undersigned subscriber to these articles of incorporation, is a natural persor competent to contract, hereby associates himself to form a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of this corporation is: Prestige Air Conditioning Services, Inc.

#### ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is: Air Conditioning and Heating Sales, Service and Repair.

To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services of every class, kind, and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.
