

### ARTICLE I - NAME

The name of this corporation is TREASURE LEASING, INC. The mailing address of the corporation is 7510 Beachview Drive, North Bay Village, Florida 33141.

#### ARTICLES II - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of Florida and the United States.
