ARTICLES OF INCORPORATION OF FOXGLOVE PUBLISHING, INC.

THE UNDERSIGNED, acting as sole incorporator of FOXGLOVE PUBLISHING, INC, under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I NAME

The name of the corporation is FOXGLOVE PUBLISHING, INC.

ARTICLE II SHARES

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, one cent (\$.01) par value per share.

ARTICLE III PRINCIPAL OFFICE

The address of the Principal Office of the corporation is 3501 Cullen Lake Shore Drive, Orlando, Florida 32812. The location of the Principal Office shall be subject to change as may be provided in bylaws duly adopted by the Corporation.
