**ARTICLES OF INCORPORATION  
OF

**THE UNDERSIGNED**, acting as sole incorporator of FOXGLOVE PUBLISHING, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I


