Articles Of Incorporation
Of
Robinson Landscaping, Inc.

In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, hereby acts as sole incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation:

Article 1: Name: The name of the Corporation is **ROBINSON LANDSCAPING, INC.**

Article 2: Duration: The duration of the Corporation is perpetual.

Article 3: Purpose: The purposes for which this corporation is organized are:

To operate a landscaping and horticulture service, plant nursery, sod and agricultural plant production facility, providing beautification and maintenance service and furnishing advice with respect to any of the foregoing; and to deal in and with real and personal property in any lawful manner anywhere in the world.

Article 4: Corporate Address: The street address and mailing address of the principal corporate office is 71 South Carolina Avenue, Cocoa, Florida 32922.




