The undersigned subscriber to these Articles of Incorporation, a natural person sometent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE | NAME

The name of the corporation shall be Alfar Group inc.

#### ARTICLE II NATURE OF BUSINESS
