ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is **AUTO PARTS UNLIMITED, INC.**

ARTICLE II - PRINCIPAL OFFICE

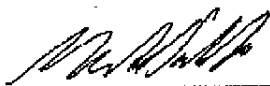
