AMENDED AND RESTATED ARTICLES OF INCORPORATION OF REAL ADVANTAGE HOLDINGS, INC.

Pursuant to Section 607.1007 of the Florida Business Corporation Act, Real Holdings, Inc., a Florida corporation (the "Corporation"), certifies that:

- 1. The original Articles of Incorporation of the Corporation were filed by the Florida Department of State on February 7, 2002, document number P02000014213.
- 2. The Articles of Incorporation are amended and restated in their entirety to read as follows:

ARTICLE I NAME OF CORPORATION

The name of the corporation is That's A Real Advantage Holdings, Inc. (hereinafter the "Corporation").

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Corporation is: 2594 Northwest 29th Drive, Boca Raton, Florida 33434.

ARTICLE III AUTHORIZED SHARES

The total authorized capital stock of the Corporation shall consist of 10,000 shares of Common Stock, par value \$0.01 per share. Except as otherwise required by law or as otherwise provided in these Articles of Incorporation each share of Common Stock shall be entitled to one vote per share. As and when dividends are so declared and paid, the holders of Common Stock shall be entitled to participate in such dividends ratably on a per share basis. In the event of any liquidation, dissolution or winding-up of the Corporation, whether voluntary or involuntary, the holders of Common Stock are entitled to share ratably in the net assets, if any, remaining after payment in full of all debts and liabilities of the Corporation and after the holders of any outstanding class or series of capital stock ranking senior to Common Stock shall have been paid in full the amounts to which such holders shall be entitled, or an amount sufficient to pay the aggregate amount to which such holders are entitled shall have been set aside for the benefit of the holders of such senior capital stock.
