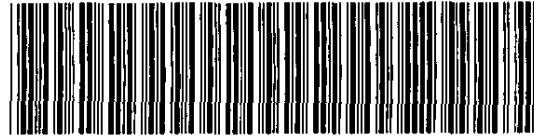

Good morning,

Our managing partner, Elliott Starman, CPA, is the Registered Agent for B.R.C. Miami, Inc. (P02000014297) and it has been brought to his attention that a typo was incorporated into the record for the name of the President of this entity. The CORRECT spelling of the last name of the sole officer and director is **BRUNETTA** and not Burnetta. A simple transposition of the second and third characters in the last name. Apparently this error dates back to the articles of incorporation but was first corrected in 2004 when the Company filed for reinstatement and Claudio Brunetta personally signed the document with the correct spelling (see www.sunbiz.org/pdf/38830038.pdf). Unfortunately, the transposition error resurfaced again in the subsequent on-line filings

Can this change be made via email notification, with reference to the above PDF or does a particular form have to be completed? Because this address ties into sunbiz.org search lookups for this name or entity we feel the error should be corrected as soon as possible and before the period for the next annual report to be filed and regret it was not caught sooner.

I have included Mr. Starman's email address in the event he needs to approve this change but I believe that the signature of and correct spelling can be taken from the sworn declaration of Mr. Brunetta filed with the Division of Corporations on March 29, 2004 (38830038.pdf).
