**ARTICLES OF INCORPORATION
OF
ALFA TEC, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of this corporation is Alfa Tec, Inc..

ARTICLE II

The term of existence of the corporation is perpetual and the corporate existence shall begin on January 1, 2002.

ARTICLE III

The street address of the principal office of the corporation is 3713B Alternate 19 North, Palm Harbor, Florida 34683

ARTICLE IV

The purposes for which this corporation is organized are to receive and maintain real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for automotive sale and repair.
