**ARTICLE I  
NAME & ADDRESS:**

The name of this corporation is **RC WORLD OF SARASOTA, INC.** and the address is **1738 SOUTH POINTE DRIVE, SARASOTA, FLORIDA 34231.**

**ARTICLE II  
DURATION**

This corporation is to exist perpetually and it shall commence its existence on the date of filing of the Articles of Incorporation with the Secretary of the State of Florida.

**ARTICLE III  
PURPOSE**




