I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

**ARTICLE I.**

The name and initial address of this Corporation shall be: BRUSH STROKE ENTERPRISES, INC., 303 N.W. 12<sup>th</sup> Avenue, Deerfield Beach, Florida 33442 with the privilege of having its offices and branch offices at other places within or without the State of Florida.


