ARTICLE I.

The name and initial address of this Corporation shall be: BRUSH STROKE ENTERPRISES, INC., 303 N.W. 12th Avenue, Deerfield Beach, Florida 33442 with the privilege of having its offices and branch offices at other places within or without the State of Florida.
