ARTICLES OF INCORPORATION
OF
ALL FLORIDA INVESTMENTS, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of the corporation is ALL FLORIDA INVESTMENTS, INC.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

PURPOSE

The purpose for which the corporation is organized is to provide construction services for profit.


