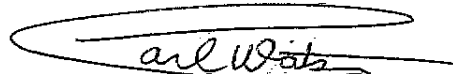

**ARTICLES OF INCORPORATION  
OF  
ANY BLOOMING THING, INC.**

**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is Any Blooming Thing, Inc. Its principal office address and business mailing address is 18220 N.E. 7<sup>th</sup> Court, North Miami Beach, Florida 33162.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock, having a par value of \$.01 per share.

**ARTICLE V - INITIAL

The number of directors may be increased or decreased from time to time by vote of the Board of Directors, but in no case shall the number of directors be less than one nor more than nine. 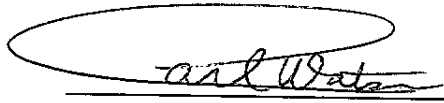
