Article VI - Board of Directors

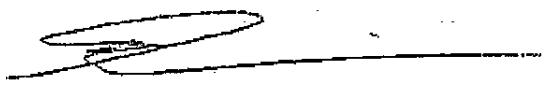
The number of directors may be either increased or diminished from time to time by the by-laws but shall never be less than one.

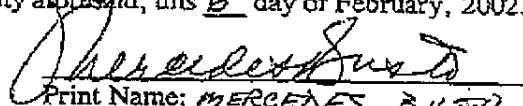
