#### ARTICLE I - NAME

The name of the corporation shall be Amper Investments Corporation.

#### ARTICLE II - PRINCIPAL OFFICE

The principal place of business/mailing address is 14842 Huntley Drive, Orlando, Florida, 32828

#### ARTICLE III – PURPOSE

The purpose for which the corporation is organized is for transacting in development and investment of franchises and other related all other lawful related business for which corporations may be incorporated under the Florida Business Corporation Act.

#### ARTICLE IV - SHARES

#### A. One Class of Stock

The corporation is authorized to issue all of its shares under one (1) class of common stock only with no authorization to issue shares of another class.
