ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be CAROLINA GROWLER OF FLORIDA, INC.,
with its principal place of business at 3139 Southeast 7th Street, Ocala, Florida 34471.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business
permitted under the Laws of the United States of America, the State of Florida, or any other
state, territory, country, or nation.

ARTICLE III - CAPITAL STOCK

The Corporation is authorized to issue ONE THOUSAND (1,000) shares of common
stock having a par value of ONE DOLLAR (\$1.00).

ARTICLE IV - PRE-EMPTIVE RIGHTS

Every stockholder, upon sale for cash of any new stock of this Corporation of the

ARTICLE VIII - BY-LAWS

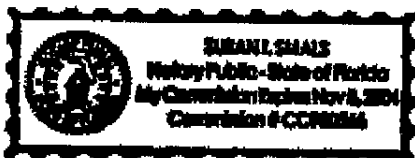
The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders.
