

Name

The name of the corporation is A. HAYDEN, INC., and its principal business address is 125 Worth Court North, West Palm Beach, Florida 33405.

The bylaws may be adopted, altered, amended, or repealed by either the shareholders or the Board of Directors, but the Board of Directors may not amend or repeal any bylaw adopted by shareholders if the shareholders specifically provide such bylaw is not subject to amendment or repeal by the directors.

Beginning of Corporate Existence

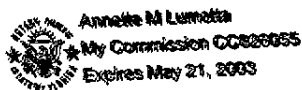




