**ARTICLES OF CORPORATION
OF
ComVest, Inc.**

The undersigned, hereby makes, acknowledges, and files the following Articles of Incorporation.

ARTICLE I -- NAME

The name of the Corporation shall be ComVest, Inc. hereinafter referred to as the "Corporation."

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Corporation shall initially be 100 E. Sybelia Avenue, Suite 105, Maitland, Florida 32751.

ARTICLE III -- DURATION

The Corporation shall commence its existence on the date these Articles of Incorporation are filed by the Florida Department of State. The Corporation's existence shall be perpetual unless the Corporation is earlier dissolved as provided in these articles of incorporation.

ARTICLE IV -- BUSINESS PURPOSE

Section 1. This Corporation is organized for the purpose of engaging in all lawful businesses permitted to a Corporation organized under the Florida Corporation Law.

Section 2. The Corporation shall have all the powers set forth in the Florida Corporation Act,

ARTICLE V -- REGISTERED OFFICE AND AGENT

The name and street address of the Registered Agent of the Corporation in the State of Florida is Mark A. McDowell, 100 E. Sybelia Avenue, Suite 105, Maitland, Florida, 32751.

ARTICLE VI -- CAPITAL CONTRIBUTIONS

The members of the Corporation shall contribute to the capital of the Corporation the money or property set forth in Exhibit "A."

ARTICLE VII -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Corporation only on the unanimous consent of all the members.

ARTICLE VIII -- ADMISSION OF NEW MEMBERS

Additional members shall be admitted to the Corporation with the unanimous written consent of the majority of the members of the Corporation and on such terms and conditions as shall be determined by said members. A member may transfer interest in the Corporation as set forth in the regulations of the Corporation, which shall provide for the consent of the other members.

ARTICLE IX -- TERMINATION OF EXISTENCE

The Corporation shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Corporation, unless the business of the Corporation is continued by the consent of all the remaining members.


ARTICLE X -- MANAGEMENT
