ARTICLE I - NAME

The name of this corporation is BASIC RENOVATIONS, INC., with its principal office and address being located at 3921 N.E. 3rd Avenue, Apt. 3, Oakland Park, FL 33334.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.

The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


#### ARTICLE X - AMENDMENT
